



REGULATIONS FOR USE OF THE SPORTS FACILITY

Municipal stadium Ettore Giardiniero Via del Mare - Lecce

EXTRACT

Art. 1 septies Legislative Decree 24 February 2003 n. 28, converted by law 24 April 2003 n. 88 and subsequent amendments; art. 4, paragraph 2 of the Ministerial Decree of 6 June 2005

PREMISE

In the stadium you experience the sporting event solely and exclusively to support your team, without racial, political, ethnic, territorial or religious prejudices. The football match represents an opportunity for spectators to come together and have fun. Anyone who enters the Stadium is animated by a healthy competitive spirit and shuns violence in every expression of him.

DEFINITIONS

By sports facility it means all the areas pertaining to the stadium, owned by the Municipality of Lecce and used by the U.S. Lecce S.p.A, including the external reserved area (so-called pre-filtering area). By sports club it means the U.S. Lecce S.p.A., professional sports club affiliated to the F.I.G.C. By sporting event it means any official sporting event of FIFA, UEFA, C.O.N.I., F.I.G.C., the football leagues, the championship and the Italian Cup, as well as international competitions, including friendly matches, which will take place in the Stadium, organized and managed. from the U.S. Lecce S.p.A. For "G.O.S." means the Security Operational Group.

GENERAL RULES OF CONDUCT

1. Access and stay, for any reason, inside the sports facility, on the occasion of the sporting event, are regulated by the "Regulations of use" and involve the spectator's acceptance of the regulations and provisions issued by FIFA, UEFA, C.O.N.I., F.I.G.C., Lega Calcio and Public Security Authorities.
2. With the purchase of the access ticket, with the release of any other access ticket (e.g. accreditation), the holder undertakes to read and unconditionally accept all the points of the "Regulations of use" of the sports facility and the "Regulation code for the transfer of access tickets", which can be found in full on the official website of the Sports Club (www.uslecce.it/biglietteria/stadio).
3. Failure to comply with this Regulation will result in the immediate termination of the service contract, with the consequent expulsion of the offender from the facility as well as the application of a pecuniary administrative sanction of 100 to 500 euros by the Prefect and, where applicable, conditions, of the ban on access to sporting events (ex art. 6 of Law 13 December 1989 No. 401 and subsequent amendments).

If the offender has already been sanctioned, in the same sporting season even in a different facility, for the same violation of the regulations of use, the sanction may be increased up to half the maximum and a ban on access to sporting events may be imposed.

3.a Without prejudice to the measures adopted by the competent Authorities against the offender and any access ban imposed, in the event of violations of the Regulations of use and incorrect, unsportsmanlike, delinquent and denigrating behaviour, the Sports Club will apply the measures provided for by the art. 7 of the Regulatory Code for the transfer of access tickets based on the "Graduation" system which provides for the application of the following measures:

- warns against compliance with the Regulatory Code and/or the rules of use;
- removal from the sports facility even during the race by the steward staff, the event management delegate or his deputy;
- suspension for one or more matches.

The measures will be decided and applied by the Sports Club in compliance with the procedure referred to in the art. 7, points B and C of the Regulatory Code, according to a gradual criterion and taking into account the extent and gravity of the facts reported. In the event of application of the measure by the Sports Club, the further aspects of relevance of the violations pursuant to current legislation remain unchanged.

4. The access ticket must be kept until leaving the stadium and shown at the request of the stewards at any time;

5. The spectator has the right/duty to occupy the assigned seat and, therefore, by purchasing the access ticket, he undertakes not to occupy different seats, even if not used by other subjects, unless expressly authorized by the organizing sports club;

6. By purchasing the ticket to the Stadium, the spectator implicitly authorizes the Sports Club and its representatives to request checks on the person and on any bags, wrappings and personal effects brought with them, including checks on the state of alcohol levels (to be part of the competent bodies), waiving any exception, and to refuse entry, or to remove from the Stadium anyone who is not willing to undergo the aforementioned checks;

PROHIBITIONS

a) Access and remain inside the facility while intoxicated or under the influence of narcotic or psychotropic substances.

b) Introduce, sell and administer alcoholic beverages with an alcohol content greater than 5 degrees ((without prejudice to different determinations and authorizations in derogation for particular areas, issued by the competent Authority, subject to the favorable opinion of the Police Commissioner)).

Transparent plastic bottles (up to a maximum of 500 ml) may only be introduced and sold if opened and without the cap. It is not possible to place drinks in other containers (e.g. water bottles, thermos, foil).

c) Stopping, lingering without reason or justified reason near passages, exits and entrances, along sorting routes, access routes, escape routes and any other escape route, as well as accessing or attempting to access areas subject to restriction to the public.

d) Climb structures and/or climb over fences, dividers and stadium structures;

e) Access with animals, with the exception of guide dogs for the blind or rescue dogs;

f) Display material that obstructs visibility to other fans or emergency signs or that in any case obstructs escape routes to the pitch;

g) Invade or attempt to invade the playing field, access prohibited areas and/or closed to the public;

destroy, damage, tamper with, deface, deface buildings, structures or other equipment/equipment and services within the sports facility;

h) Express any form of racial, ethnic, territorial or religious discrimination or other manifestations of intolerance with chants or display of graffiti;

i) Organize unauthorized choreographies or choreographies that differ from those authorized by the Security Operations Group (GOS) at the request of the Sports Club.

The staging of choreographies, the introduction of banners and any other similar material, single-beat drums, megaphones and flags (with a flexible plastic pole measuring up to 150 cm), except for those bearing only the colors of their own team and that of the states represented on the field, must be previously authorized by the G.O.S. (Safety Operational Group) assessed the environmental context and the number of requests received.

> It is absolutely forbidden to introduce or possess, for example:

1) flammable and soiling materials and substances, poisons, harmful substances, drugs, firearms or instruments capable of offending, explosives, smoke bombs, firecrackers, fireworks, gunpowder, rockets, torches and flares, sound and musical instruments; marbles, nuts, screws, bolts, sticks, hammers, screwdrivers, various tools, chains, cans, bunches of keys and bulky key rings; camera stands, selfie sticks; video cameras, reflex cameras, interchangeable zooms or other accessories unless specifically authorized in advance by the Sports Club, medium and large sized binoculars (small sized, "theatre" type binoculars are permitted), drones, bulky luggage such as ice chests, suitcases, motorcycle helmets; strollers, cots or similar unless specifically authorized in advance by the Sports Club, foldable bicycles, skateboards, skates, systems for emitting light rays (laser pointers); crutches, subject to express authorization from the Sports Club.

2) umbrellas, with the exception of those of small dimensions, in any case not having sharp tips and of shapes and/or materials that could cause danger to the safety of the event and spectators;

3) Banners, placards, banners, double-staffed flags, weather vanes, documents, drawings, printed or written material other than those explicitly authorized by the Security Operations Group (GOS) upon request of the Sports Club (determination no. 14/2007 of the National Observatory of Sports Events of the Ministry of the Interior); they cannot however be displayed in spaces other than those indicated by the sports club and must be removed at the end of the event; It should be noted that the following behaviors, in addition to being subject to administrative sanctions as they constitute a violation of this regulation, also constitute crimes: - misrepresentation; - possession of own and improper weapons; - display of emblems or symbols of

associations that spread discrimination or violence for racial, ethnic, national or religious reasons; - incitement to violence during competitive competitions; - possession, throwing and use of dangerous material and pyrotechnic devices; - climbing over separators; - pitch invasion.

WARNINGS.

The system is controlled by a video recording system positioned both inside and outside the structure, whose images are treated according to the provisions of Italian and European legislation on the protection of personal data (EU Regulation 2016/679) and subsequent provisions of the Guarantor Authority.

The registration is carried out, for purposes of public order and safety and for the prevention and detection of crimes, by the U.S. Lecce S.P.A. through the Police Authority, in accordance with the provisions of the code regarding the protection of personal data and the Decree of the Ministry of the Interior of 6 June 2005.
